## Drax estimates financial impact

**Drax Group has estimated the potential financial impact of Covid-19 on their business operations could be as high as £60million, as they look to continue powering the UK during the pandemic.**

This estimate from the energy giant comes after their trading figures were released last week, which also showed that the company's performance in the first three months of 2020 was financially strong.

While the impact of Covid-19 is still unfolding, the Group's expectations for 2020 are currently in line with consensus inclusive of an estimated potential impact from Covid-19 of £60 million, which they say is down to

lower power demand and increased bad debt risk in customers' businesses.

Within the figures last week, Drax Group also said that the performance of the company would depend on the continuation of biomass deliveries to Drax Power Station. Biomass generation is currently the most material area of activity for the Group and a protracted suspension of the supply chain could lead to lower levels of biomass generation, resulting in a reduction in the Group's expectations for the full year.

Currently, there has been no impact from Covid-19 and the Group has a good supply of biomass throughout the supply chain, which has been strengthened by the reopening of the main rail line into Drax Power Station after flooding in February in March caused extensive damage to the network.

Will Gardiner, Drax Group CEO, said: "With our strong balance sheet, robust trading and operational performance, and resilient sustainable biomass supply chain, Drax is in a strong position to support its employees, business customers and communities during the Covid-19

crisis, while continuing to generate returns for shareholders.

"As an important part of the UK's critical national infrastructure, we recognise our responsibility to support the country's response to Covid-19. We have strong business continuity plans in place and are in close contact with the UK Government. Our dedicated teams across England, Scotland and Wales, supported by our US biomass colleagues and business partners, are working around the clock to generate and supply the flexible, low-carbon and renewable electricity the UK needs, not least to the 250,000 businesses, including care homes, hospitals and schools we supply.

"The Group is also providing support for communities and others affected by Covid-19.

"Nevertheless, it is still early in this pandemic. As Covid-19 continues to develop, we remain vigilant in looking to protect all our stakeholders and will report further if there are significant changes to our outlook for 2020."

## Manufacturer helping in fight
